ABOUT THE 9/11 LIVING MEMORIAL PROJECT

The **9/11 Living Memorial Project**, (LM) currently on line at www.voicesofsept11.org, chronicles the lives of the nearly 3,000 lost, and documents firsthand accounts of rescue workers and survivors at the World Trade Center, the Pentagon and Shanksville, PA. The archive includes memorials and foundations and will expand over time to showcase the caring, courage and compassion the world experienced that day. Audio and video such as oral histories and family videos will be included.

VOICES professional staff has met one-on-one with over 700 families and provided individual support through the healing process of creating a meaningful tribute that commemorates the life of their loved ones and documents their personal stories. Since the LM Project was launched **VOICES** has conducted several hundred workshops throughout the tri-state area, Washington, DC, Pennsylvania and Massachusetts. In November, 2009 **VOICES** began our international outreach by meeting with 9/11 families living in London.

As a result of our work, families have contributed over 30,000 photographs, written materials and personal keepsakes. The **9/11 Living Memorial Project**, featured by the **Clinton Global Initiative**, will become a core component of the exhibits at the **National September 11th Memorial Museum** at Ground Zero, the Library of Congress and other institutions.

THE RT HON. TONY BLAIR

Tony Blair was Prime Minister of the United Kingdom from May 1997 to June 2007.

Since leaving Downing Street, Tony Blair has served as the Quartet Representative to the Middle East. He represents the USA, UN, Russia and EU, working with the Palestinians to prepare for statehood as part of the international community's effort to secure peace.

In May 2008 he launched the Tony Blair Faith Foundation which promotes respect and understanding between the major religions and makes the case for faith as a force for good in the modern world. His Africa Governance Initiative delivers projects in Rwanda, Sierra Leone and Liberia, advising the leaders and their governments on policy delivery and attracting investment.

As the first major head of government to bring climate change to the top of the international political agenda at the 2005 G8 summit, Tony Blair works with world leaders to build consensus on an international climate policy framework. In recognition of his debt to the North East of England, he has launched The Tony Blair Sports Foundation, to increase opportunities for young people to participate in sport.

He is married to Cherie Booth QC, and they have four children.

About Voices of September 11th

Voices of September 11th (VOICES) was co-founded by 9/11 family members Mary Fetchet and Beverly Eckert immediately following the attacks on September 11th. Currently led by Ms. Fetchet, a clinical social worker who lost her 24 year old son Brad, the organization provides information and resources to over 10,000 9/11 families, rescue workers and survivors. VOICES services include teleconference support groups, case management services, an e-newsletter and an annual September 10th Information Forum and September 11th Commemorative Luncheon in New York City. VOICES supported the creation of the 9/11 Commission and legislation based on its recommendations, with a focus on promoting preparedness on the local, state and federal levels. In 2006 VOICES launched the 9/11 Living Memorial Project which commemorates the lives lost and documents firsthand accounts of rescue workers and survivors.
