## Dear 9/11 Family Member:

On September 10, 2010, Governor Martin O'Malley announced the intention to create a Maryland 9/11 Memorial on the plaza of the World Trade Center in Baltimore's Inner Harbor. It will honor the extraordinary heroism, commitment and sacrifice of Maryland 9/11 victims, responders, and their families; and pay special tribute to the Marylanders who lost their lives that day. It will also provide a place of contemplation to reflect and remember. It is with honor that I accepted Governor O'Malley's appointment as the Chair of the Maryland 9/11 Memorial Committee.

An artifact from the Twin Towers will be the centerpiece of the Memorial. A competitive process was undertaken to select the most qualified team to design, build, and install the Memorial. In January 2011 the Baltimore architecture firm, Ziger/Snead, was chosen among a number of nationally known design teams. The Memorial will be completed this summer and dedicated on September 11, 2011.

As the design progresses to its final stages, we want to include the names of those who were residents of Maryland when 9/11 occurred, as well as any person who considered himself or herself a "Marylander." We are therefore sending this letter to all of the 9/11 families to see if there are names we should include in addition to the 51 names we have thus far. Please take a moment to review the list attached.
