Survivors

Who is Eligible?

- A Survivor is a person who was present in the New York City disaster area (see map on front) in the dust or dust cloud on September 11, 2001
- A person who worked, lived, or attended school, child care, or adult day care in the New York City disaster area
- A person who was eligible to receive a grant from the Lower Manhattan Development Corporation Residential Grant Program, who had a lease for a residence or bought a residence in the New York City disaster area, and who lived in that residence during the period beginning on September 11, 2001, and ending on May 31, 2003
- A person whose place of employment was in the New York City disaster area and was eligible to receive a grant or other government incentive program during the period beginning on September 11, 2001 and ending on May 31, 2003

Why should you apply?

- If you have an illness that's determined to be related to the attacks on 9/11, you will receive health care for that condition
- The health care will be provided at no out of pocket cost to you from a WTC Health Program physician
- You will be eligible for medical care, mental health care and prescription medications for covered conditions
- You will receive high-quality medical care from practitioners experienced in 9/11 related diseases at one of the Clinical Centers for Excellence
- If you live outside the New York metropolitan area, you will receive medical monitoring and treatment from the Nationwide Provider Network
- Monitoring your health care will help inform medical professionals about the treatment of 9/11-related medical diseases

Responders

Who is Eligible?

- A Responder is a person who performed rescue, recovery, demolition, debris cleanup or related support services in lower Manhattan (south of Canal St.) the Staten Island Landfill, or the barge loading piers
- A member of the Police Department of New York City (active or retired) or a member of the Port Authority Police of the Port Authority of New York and New Jersey (active or retired)
- An employee of the Office of the Chief Medical Examiner of New York City
- A worker in the Port Authority Trans Hudson Corporation Tunnel
- A vehicle-maintenance worker who was exposed to debris from the former World Trade Center while retrieving, driving, cleaning, repairing, and maintaining vehicles contaminated by airborne toxins from the September 11, 2001, terrorist attacks

- 2) Mail completed and signed application with documentation to the address/fax listed
- 3) Application and documentation is reviewed for eligibility and completeness
- 4) Eligibility confirmed or denied
- 5) Clinical Center of Excellence selected
- 6) Health screening appointment made by the clinical center site
